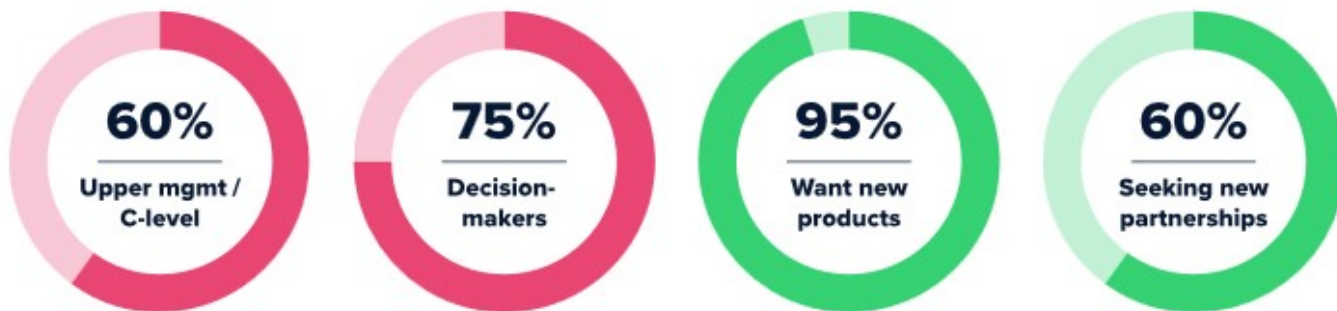

We decided the best way to solve this problem is to bring specific awareness to assisting families of infants during their loss. Kim has devoted her life to Empower, Educate and Inspire families to be the best that they can be while providing education and resources to overcome individual and family struggles. Saving families Worldwide was founded to service families and individuals in the community. The Josiah David Project is an affiliate program and dedicated to Kim's infant son that passed away, Josiah David. Join us as we celebrate families at the gala.

We have come a long way in efforts to assist families, but we still need your support. When the temperature is not regulated and kept cool, babies' bodies begin to deteriorate after delivery. There are approximately 177 hospitals in the Houston Metropolitan area yet only 1 has a cuddle cot to service families that experience loss after childbirth. Parting with a stillborn baby is the first step in a long and difficult grieving process, one that can take a lifetime to come to terms with.

The majority of gala funds raised go toward donating Cuddle Cots to local hospitals, and assisting families.
